We wish to inform that pursuant to the Act *on construction products* of 16 April 2004 (Journal of Laws No. 92, item 881 as amended), loft ladders <u>are not construction products</u> as **they have not been included in** the subject matter of any of the European Commission's **mandates for drafting harmonised standards** and **guidelines for European technical approvals**. As a consequence, for the aforementioned products, **marketed after 1 May 2004**, there cannot be issued any technical approvals, as they are not subject to the act on construction products. Hence, they are under no obligation to be marked with CE or B construction sign or have issued any National declaration of conformity or the declaration of performance.
